

As your funder, Futuro Health has expectations for success and conduct that will need to be upheld to continue to receive funding.

As a Futuro Health scholar it's important that you maintain your grades and pass your courses. If you fail a course in your program, you will be required to submit a retake request to return. The request may or may not be approved so it is essential that you dedicate adequate time to your studies and courses. If the request is not approved, you will need to continue at your own expense if you'd like to complete your program.

As a scholar it is expected that you meet conduct standards of the Educational Provider. We will not tolerate reports of plagiarism, disrespect for classmates, coaches, or instructors, or physical violence. We will support any action the Provider takes when these things are reported. In these scenarios, even if the Educational Provider allows you to continue, your funding will be at risk for termination, and you could be responsible for the remaining cost of your program.

Futuro Health believes strongly in promoting the development of personal, professional, and social responsibility. Futuro Health also believes in a humanistic approach to discipline conducive to academic pursuits. However, Futuro Health recognizes that its responsibility for the protection of personal and institutional rights and property is a primary focus of the disciplinary process. Behavior that infringes upon rights, safety, or privileges, or that impedes the educational process, is unacceptable and may lead to sanctions up to and including dismissal from the program. Courteous behavior and professional conduct, appropriate to a business environment, is to be always displayed, whether in person or virtually. All students are expected to respect the rights of others and are held responsible for conforming to the laws of the federal, local, and State governments. Students are expected to conduct themselves in a manner consistent with the best interests of Futuro Health and of the student body.

Futuro Health reserves the right to develop any policy or take any action(s) deemed appropriate to maintain the safety and well-being of any or all students. Student conduct offenses may be related to persons, property, campus operations, and welfare, and the health or safety of students, faculty, and staff.

Students are encouraged to share personal experiences while participating in programs funded by Futuro Health. However, students must be aware that should they disclose to any Futuro Health staff information that may cause harm to themselves or others, faculty members and staff are required to report such information.



Every student is subject to federal and state law and respective county and city ordinances. A student who is convicted of any criminal offense which interferes with the orderly operation of the school or which the administration feels would endanger members of the Futuro Health community shall be subject to disciplinary action.

Examples of infringing on the code of conduct, but not limited to:

- Intentionally or knowingly and without authority or consent limits or restricts the freedom of a person to move about in a lawful manner.
- Threatens (by any means), intimidates, or uses physical or sexual force in a manner that endangers the health or safety of another person, or which reasonably causes another person to be fearful of physical or emotional harm.
- Intentionally harasses another person. Harassment includes, but is not limited to, impeding another persistently or wronging or bothering another persistently.
- Engages in any activity related to other persons which is prohibited by law or court order.
- Knowingly and without consent or authorization possesses, removes, uses, misappropriates, or sells the property or services of another person or of Futuro Health.
- Intentionally or negligently damages or destroys property owned or in the possession of another person or of Futuro Health.
- Obtains the property of another person by misrepresentation or deceptive means.
- Enters or uses the facilities or property of another person or Futuro Health without consent or authorization.
- Commits a computer-related offense, including, but not limited to, use of a Futuro
  Health computer to access graphically prurient or sexually explicit images of persons
  and/or children.
- Uses, possesses, or manufactures, without Futuro Health authorization, firearms, explosives, weapons, unregistered fireworks, illegal chemical or biological agents or other dangerous articles or substances injurious to persons or property.
- Uses, possesses, distributes, sells, purchases or is under the influence of alcohol, narcotics, hallucinogens, dangerous drugs, or controlled substances.
