Human Touch Healthcare (HTH)

Course Description

Course Overview and Purpose: The Human Touch Healthcare course is a six-week, online program designed to develop the interpersonal skills essential for success in allied health careers. This course emphasizes the importance of “soft skills” in healthcare environments, including effective communication, empathy, professionalism, and collaboration.

Students will engage in guided discussions, simulations, and scenario-based activities to explore how interpersonal skills impact patient care, workplace relationships, and team dynamics. By the end of the course, students will have a deeper understanding of the interpersonal competencies necessary to thrive in healthcare settings.

Prerequisites: No required prerequisites.

Course Objectives

This course is designed to provide students with a comprehensive understanding of the essential soft skills required to succeed in today’s healthcare environment. Throughout the curriculum, students will explore key concepts and principles that are essential for their development. They will acquire practical skills, engage in critical thinking, and gain valuable insights that will empower them to apply their knowledge in real-world situations. By the end of the course, students will be well-equipped with the tools necessary for success in their future endeavors.

3. Apply clear, empathetic, and culturally responsive communication strategies that promote trust, understanding, and inclusive, patient-centered care across diverse populations.
4. Evaluate personal cultural awareness and implicit biases to develop equitable, culturally responsive practices that respect the diverse values and beliefs of patients and colleagues.
5. Apply teamwork and conflict-resolution strategies to foster inclusive collaboration, clarify roles, and contribute to high-quality, coordinated care.
6. Engage in critical self-reflection and incorporate feedback to enhance communication, strengthen ethical practice, promote empathy and cultural responsiveness, and support professional development.

- **Late Assignments:**

- Assignments submitted within 24 hours after the due date will be eligible for a maximum of 80% of the total points.
